Session 1

- CoC refers to both the Planning Body and the Federal funding stream
- Key Roles of a CoC:
 - 1. Prevent & End Homelessness
 - 2. Oversee the required data management system (HMIS)
 - 3. Provide oversight to its Coordinated Entry (or CE) system
- Homeless Population Data
- Racial Disparities within the Homeless Response
 System

Session 2

Infrastructure of a CoC:

HMIS: data base which collects homeless services data and produces the reports required by HUD.

Coordinated Entry: approach to coordination and management of housing and supportive services

Collaborative Applicant: submits the CoC-program funding application, supports CoC operations, and provides best practices for homeless services

CoC-program Funded Agencies: local homeless service providers who develop affordable housing opportunities and support services

- Identify common goals for which to advocate
- Increase community "buy-in" and access to mainstream resources

WHY MIGHT SOMEONE BE A COC MEMBER OR BE ON ITS BOARD?

- You have a personal/professional commitment to ending homelessness
- You want to improve the local homeless response system based on your lived experience of going through the system
- You strive to ensure CoC membership reflects the diversity of populations experiencing homelessness
- You are bringing your expertise and ideas on how to improve the homeless response system
- You wish to collaborate with homeless service providers to end homelessness
- It is part of your job position/role at your organization to participate within the CoC
- You want to promote and inform the community on your organization's service offerings
- Because you interface directly with persons experiencing homelessness but are not primarily a homeless service organization (ie: EMS, Police, Fire Fighter etc.)

WHAT IS MY ROLE IN THE COC?

WHAT PERSPECTIVE AM I BRINGING?

- Listen to the community's perspective and needs on homeless issues
- Representing an organization or government entity you work for.
- Representing the community you reside in or work within.
- Representing folks who have experienced or are currently experiencing homelessness.



HOW CAN I CONTRIBUTE TO THE COC?

- Participate in the Membership meetings
 - Provide updates on your homeless programs and other related initiatives
 - Provide feedback when local priorities are discussed and strategized
 - Discuss local homeless service funding opportunities and areas for need
- Participate in a Committee
 - Execute the strategic plan tasks/activities
 - Work collaboratively with homeless service providers on projects that improve the CoC system and further CoC initiatives
- Participate in Trainings and Workshops
 - Lend your expertise to the CoC membership
 - Streamline your program referrals
 - Improve your understanding of complex issues and learn new approaches for the best service delivery 9



HOW THE COC ENGAGES ITS MEMBERS

- Providing training materials for new and current members to understand the mission, purpose, and function of the CoC
- Voting on policies and procedures of homeless service programs
- Reach out to organization with boots on the ground experience to contribute to discussion and funding priorities
 - Include staff at all levels to participate, not just Managers and Executive Directors



CHAIR ROLE & RESPONSIBILITIES

Board

The Board chairs provide leadership to the CoC to achieve its goals and mission.

The SNC Bylaws state there will be two Chairs of the CoC Board representing the Coalition.

Committee

Committee co-chairs provide leadership and oversight to their respective Committee





Access

Access to apply and/or collaborate with others for grant and funding opportunities

Access to homeless and at-risk data from the Homelessness Information Management System

Access to the Coordinated Entry system to assist with placement of homeless clients or fill openings quickly from the CE list

Access to training, educational, and technical assistance opportunities



Support

Learn and share best practices for serving homeless and at-risk homeless households

Ability to receive letters of support on behalf of the housing providers in the CoC area

Expert guidance through the HUD NOFA (notice of funding availability) application process



Community

Opportunities to network with other homeless service stakeholders, providers, and community advocates

Participate on local task force groups and committees

Participate in strategic planning

Provide a platform for voices and experiences of people who are experiencing homelessness
